All of them will be on your primary ballot in June - and let your unaffiliated friends know that they can vote in the BoE primary as well!

Think about putting your name on the ballot, too, or reach out to a friend and suggest it. In addition to the BoE, we have empty spots in legislative district 4 and 2A, as well as in the courthouse. Ever thought of running for Judge of the Orphans' Court? It's a part-time position, open to any registered voter and high school graduate. And of course, you could run for

# COUNTY COUNCIL MEMBER JESSICA FITZWATER

We were all hoping that 2021 would have marked the demise of COVID-19. But in recent months, the Omicron variant has pushed Frederick County and Maryland into record numbers of cases and hospitalizations.

As a member of Frederick County's Board of Health, I- along with my colleagues on the County Council and County Executive Jan Gardner — have had to make many difficult public health decisions during the past two years. Our actions have been based on the strong scientific recommendations laid out by our Frederick County Health Officer Dr. Barbara Brookmyer and her outstanding team.

I'm proud of the work we've done on a bipartisan basis. Our health department has provided daily free COVID testing at its Hillcrest location and offered free vaccines at the Himes Ave. location (formerly Oak Street). But we've also established pop-up clinics in rural communities, partnered with many nonprofits and engaged folks at community events, and established a full-time satellite office of the Health Department in the Hillcrest area.

As a result of these efforts, over 93% of people over 65 are fully vaccinated, as are over 80% of adults over the age of 18. Our health department administered over 90,000 COVID-19 vaccines during 2021 alone. But there's still more to do, and we will have to maintain vigilance until the pandemic abates.

It's also important not to lose sight of the other aspects of our public health mission — everything from encouraging regular immunizations for our kids, to improving pre- and postnatal care, to offering essential mental health services and drug recovery programs, and so much more. We are fortunate to have the assistance of many nonprofit organizations who help us extend the reach of public health.

I was pleased to join over 150 community members, health care providers, non profit advocates, policy makers, business leaders, and more for the Frederick County Health Priorities Public Input Session last month. This event focused on five health priorities based on local data—Adverse Childhood Experiences (ACEs) in Adolescents, Diabetes Type 2, Lack of Early Prenatal Care, Mental Health, and Obesity—and gathered input through breakout groups. By analyzing the resulting input, work groups will be established that will inform the work of the Local Health Improvement Process.



One extremely important initiative that is now getting underway is a study and strategic planning effort to address and eliminate maternal and infant health outcome disparities experienced by Black and Brown mothers in Frederick County. This new initiative is moving forward through the leadership of a grassroots group of local mothers, Brown Mamas Building Bridges, and I'm proud to say it is one of the first projects the County is funding with American Rescue Plan Act funds.

Access to healthy food must also continue as a priority. Through the collaborative work of nonprofits and many others, food has been distributed at 80 locations around the county, and we've significantly expanded delivery to seniors through our Meals on Wheels program. These efforts led to FeedingFrederick.com, a resource that uses GIS technology and community partnerships to map out food distribution sites and food banks throughout the County.

We cannot overlook the impact the environment and our changing climate has on our community's health. Air and water quality, availability of locally grown food, weather events and flooding, and many other factors will impact Frederick County in the years to come. Through recommendations from the County's Climate Emergency Mobilization Work Group Final Report, County Executive Gardner and the Council are moving ahead with a significant expansion of our Office of Sustainability and Environmental Resources.

Public Health is one of the four key components of our Liveable Frederick Master Plan and is essential in helping us realize our shared vision for 2040: Frederick County is a vibrant and unique community where people live, work, and thrive while enjoying a strong sense of place and belonging. We must keep public health at the forefront of our decision-making, not only as we continue to navigate the COVID-19 pandemic, but beyond.

# DELEGATE KAREN LEWIS YOUNG

Reviewing and revising the Governor's proposed budget is one of the most important tasks of the state legislature. Last week, the Appropriations Committee began its work on next year's budget for Fiscal Year 2023 (FY23). The Senate moves the budget first this year.

Spending in the Governor's FY23 operating budget proposal totals \$58.2 billion, approximately 5.5% less than fiscal 2022, with cash reserves over \$4.0 billion.

While the State's General Fund grew by 21.9%, overall spending declines in fiscal 2023 as the temporary stimulus from the federal government ends.

The budget does not include funds from the federal Infrastructure and Jobs Act, which is expected to provide approximately \$3.0 billion of new funding over a five-year period.

Education is not fully funded. The Governor's FY23 budget does not include \$125.0 million in funding for the Education Effort Adjustment component of the Blueprint (Kirwan). The budget also fails to fund \$15.0 million in other Kirwan programs. Notwithstanding the underfunding, education funding still increases by \$263.0 million or 3.6%.

"Record levels of funding" is often code for mandated spending or formula-driven investments created by the Maryland General Assembly.

The budget provides \$832.0 million for enhancements to State employee compensation. This is much needed considering the

Administration has been unable to fill over 10% of its positions, which is a significant safety concern for Marylanders.

The budget also provides \$60.0 million to assist childcare providers and support the child care subsidy program.

The Governor's proposal includes funding to keep tuition increases at Maryland public colleges and universities at 2%. This continues a trend started by the General Assembly in 2006.

The Governor has also included perennial tax cut proposals, including a proposal to phase out the income tax on retirement income. This proposal would, by fiscal year 2027, cost the State nearly three-quarters of a billion dollars that could jeopardize funding for programs like the Blueprint.

The Governor is also proposing an extension of the earned income credit enhancements passed last year by the General Assembly in the Relief Act – this proposal, however, does not include individual taxpayer identification number (ITIN) filers. Our current EITC and ITIN enhancements could be extended in the 2023 legislative session without interruption.

These points are just a few highlights from initial observations. Although I do not serve on a budget committee, many of my health care initiatives are dependent on budget funding. I have already been working with my colleagues, who serve in leadership positions on both budget committees, to increase funding for education, health care, and housing insecurity.

# ALDERPERSON KATIE NASH



Your Democratic Mayor and City Aldermen have been hard at work in our first month of this Administration. I am particularly proud of our December 15th budget priority presentations - your members of the Board provided a comprehensive and inclusive agenda for the upcoming year. These priorities are now being used to drive the City's 2022 legislative agenda for members of the Board and I invite our Democratic activists to partner with us in this work. Although the Board of Aldermen is a part-time legislature, we have full-time priorities. I hope to use my Banner submissions to update everyone on the great work of your City Democratic leadership. We will continue to work together as a team to communicate the positive impact of local government.

As our 2022 agenda forms, we are taking a fresh look at our City legislative process as well. In the last four years, the all-Democratic Mayor and Board of Aldermen made important investments to expand access to government. This work continues! Now we are working on creating a transparent and formalized process to increase resident engagement and visibility for legislative priorities. As legislation moves through the introduction, edit, debate, amendment, and approval phases, there should be a mechanism for stakeholders to track legislation and weigh in. Creating a new process with limited resources during a pandemic takes effort and there is no "quick fix". I imagine there are a lot of good government nerds reading this - your input is most welcome as we work through this project.



# DELEGATE KEN KERR

Greetings from Annapolis. We convened the 444th Maryland General Assembly on January 12. In all, I have 11 bills before the MGA this session, and I will explain a little bit about a few of them. But first, let's discuss legislative redistricting.

Each decade, as a result of the US Census, The Governor and Legislature draft redistricting maps. As the Democrats have supermajorities in both chambers, the committees in both the House and Senate submitted and approved a different map from the governor. Frederick County grew faster than any other county these past 10 years, and my district, 3B, grew faster than any other district at over 17%. As a result, I knew the boundaries of my district were going to shrink. What I didn't know was that the legislature would combine the remaining parts of my single–member district 3B with the two-member district 3A making a three-member district. Currently, there are 5 of us running for the 3 seats in the newly redrawn District 3.

While Frederick grew in population, Allegany and Garrett Counties lost population and had to push deeper into Washington County to find sufficient population for District 1. That means Washington County did not have enough remaining population to form District 2 and had to encroach on Frederick County District 4 to find enough people (about 132,000) to make up that district. Thurmont, Sabillasville, Emmitsburg, and Rocky Ridge will now be part of District 2. This means the Frederick County Delegation to Annapolis will grow by 2 for a total of 10, with two people in our delegation who do not live in Frederick County. As of January 25, there were no Democrats running for senate or delegate in District 4 which now includes Braddock Heights, Jefferson, Adamstown, and Point of Rocks.

The deadline to file for office is February 22 As for my Bills:

HB 136 Seizure Safe Schools—Brynleigh's Act requires that all public school personnel who have contact with children complete a 45-minute training from the National Epilepsy Foundation to recognize the symptoms of a child having a seizure and know how to respond. One-in-ten people will have a seizure at some time in their lives and 7,900 children in Maryland Schools live with epilepsy. Additionally, the #1 emergency in schools is seizures. Senator Young is my senate cross-file.

Statewide 3-1-1 establishes a one-stop point of contact to access all government services. Currently, 37% of all calls to 9-1-1 are not emergencies. Rather, many of these calls are requests for the state, county, and local services. Statewide 3-1-1 will alleviate that strain on 9-1-1 resources and provide a high level of customer service.

A final bill I will discuss is the Maryland Physicians Assistant Modernization Act. The regulation of the practice of a Physicians Assistant (PA) has not been addressed in some time. They don't take into consideration changes in technology, and regulations for physicians that intersect with PAs do not agree. There are also burdensome requirements for a PA to move from one practice to another. At a time when access to care is an increasing problem, modernizing the laws that regulate PAs will go a long way to address that.

I'll follow up next month with an update on these bills and talk about a few more. Stay warm, stay safe, and stay healthy.

As I was trying to organize some of my stuff (and I have lots of stuff), I came across this program "Super Saturday – Maryland Democrats Working" about a conference that was held in 1987. Quite frankly I have no recollection of this event despite the fact that I was on the planning committee and the program. What struck me as I was looking at the program is how many of the persons involved are still active in politics (thirty-four years later this past December) including Joel Rozner, Delores Kelley, John Willis, Peter Franchot, Tom McMillen, Maggie McIntosh, Casper Taylor, Jr., Parris Glendening, Beverly Byron, Liz Bobo, Steny Hoyer, Lanny Davis, Jim Kraft, Ellen Moyer, Greg Pecoraro, and Mary Jo Neville (I may have missed some, but you get the idea). It shows that some people have politics in their veins.

#### We have lost a great one

I am so sorry to report the death of my good friend Stephen Sachs at age 87. He was a top-flight lawyer and was hired by U.S. Attorney Joe Tydings to work in the U.S. Attorney's office after President Kennedy appointed Tydings to be the U.S. Attorney General for Maryland in 1961. Steve was United States Attorney himself from 1967 to 1970 and Maryland Attorney General from 1979 to 1987. He argued cases before the Supreme Court three times. After serving two terms as Attorney General of Maryland he unsuccessfully sought the Democratic nomination for Governor of Maryland but was defeated in the primary by William Donald Schafer. After he slowed down his high-powered practice as a lawyer, he championed the cases of those on death row who he felt had been unfairly convicted, the mentally disabled, and the indigent, often on a pro bono



basis. I first met Steve in the early 1970s. We were among a small group of people who served as a steering committee for former Senator Joe Tydings' attempt to secure the Democratic nomination for his old seat in the Senate in 1976 (then-Congressman Paul Sarbanes was the winner). Steve was known for his kindly demeanor, fierce intelligence, withering wit, progressive politics, love of history, and loyalty to his friends. The Daily Record reports that Congressman Anthony Brown considered Sachs "an extraordinary mentor." Maryland Attorney General Brian Frosh called him "a champion of civil rights, ... a superbly talented lawyer," and former Maryland Attorney General and candidate for governor Doug Gansler called him "a legend in state attorney general circles." Baltimore Sun columnist Dan Rodricks said, "Steve Sachs had integrity in his bones." Former delegate and super lawyer Tim Maloney is quoted in the Baltimore Sun as describing Sachs as "a magnificent lawyer and an even better human being." Sachs was all those things and more. 🌊

# CANDIDATE: JULIANNA LUFKIN



I have served as Chief Deputy Register since 2010, and have assisted two Registers in developing an office that is responsive to the needs of our constituents. For most people, the need to contact the Register corresponds with some of the hardest times in their lives. Sensitivity and awareness are required; knowledge of the law, even

more so. Estates and Trusts have historically been a quiet area, however, over the past decade, the legal landscape has become much more complicated and litigious.

I am an attorney who has worked in estates & trusts exclusively since my admission to the bar in 2003. Attorney licensure is invaluable in this quasi-judicial position. During my tenure, we have received three "crystal clear" audits from the Office of Legislative Audits, and remit several million dollars annually to the Comptroller.

I hope to be your next Register and ask for your vote to continue to serve the needs of Frederick County families during some of their most sensitive moments.





#### 2022 Maryland Primary for Central Committee Candidates of the Democratic State Central Committee of Maryland

The Democratic State Central Committee of Maryland elects the **fourteen (14)** members of Frederick County by a countywide vote of their Democratic voters during the Gubernatorial Primary on **June 28, 2022**. Membership of the committee allows for representation of three (3) gender categories; **Male, Female, & Non-Binary.** When filing for candidacy, candidates will identify their preferred gender identity, which will appear on the official ballot alongside their names. **All candidates will appear under one ballot title.** Elections of the committee shall allow for gender balance ensuring that **no more than fifty (50) percent of the membership** is represented by one of the three (3) gender categories listed above.

#### **Three Gender Categories:**

Each candidacy filing form will show THREE (3) categories Male, Female, & Non-Binary. Non-Binary: "non-binary" is one term people use to describe genders that don't fall into one of these two categories, male or female.

#### What does gender balance mean?

Gender balance allows for equal representation between genders. The election process will take into account both vote total and gender representation. Through the election process, the committee will be considered gender balanced as long as there is **no greater than a variance of one (1)** between **Male** and **Female**, as **Non-Binary** will not count as either **Male** nor **Female**.

#### What DOES this mean:

- No more than a maximum of seven (7) members can be Male, Female, or Non-Binary.
- Candidates WILL have their preferred gender identity listed on the ballot with their names.
- In the case that a Non-Binary candidate wins a spot on the committee, the remainder of the
  committee will be balanced as equally as practicable between male and female with the remaining
  candidates on the ballot.
- There are no guaranteed slots to any one gender. Meaning the allocation of members is solely determined by vote total and gender balance allocation.
- There is **NO** advantage or disadvantage to selecting a specific gender category.

### Role of Maryland Democratic State Central Committee Members

Central Committee members are the grass roots-level elected volunteers of the Maryland Democratic Party. They must be dedicated to working to ensure the election of Democrats to public office, while encouraging the participation of activists, volunteers and financial contributors. This calls for many hours of participation, and in some cases a financial commitment themselves.

They should bring to the Central Committee a strong commitment to the Democratic Party and all the things it stands for. Central Committee members should have volunteer experience in various political activities, worked for candidates, or run for office themselves.

Central Committee members are the people elected to work directly in the trenches on behalf of the Democratic Party and to organize an ongoing presence at the local level. They are the people who do the organizing and actual tasks of helping get Democrats elected. Central Committees members are not legislators. They are not managers or members of a board of directors, but worker bees themselves. They help organize and fulfill these tasks:

Fundraise, staff party booths/events, precinct organization, participate in canvassing operations, distribute political literature, perform voter registration, phone bank, and assist hands on in all of the tasks necessary for Democrats to be successful in elections.

Central Committee members have an obligation to attend all committee meetings, support party nominees, and to actively participate in all the activities of the State and Local Central Committee. Central Committee members at no time can openly support a candidate of another political party in a partisan race.

Central Committee members cannot do all that must be done by themselves, they must reach out and recruit volunteers to assist in many of these activities and tasks. Recruitment of volunteers therefore becomes the difference between success and failure. Central Committee members must have good motivational and organizing skills to make use of these volunteer resources.

As a member of the local Central Committee individuals are automatic members of the State Central Committee and are expected to attend Semi-annual meetings, vote on State Party issues and participate in State Party projects.

Central Committee members have the official responsibility to fill vacancies of certain offices due to death or resignation of elected official, and fill any vacancy when there is a failure to have a Democratic Candidate file for nomination. The Central Committee also recommends to the Governor appointment of the members and substitute members for the local County Board of Elections and at times makes recommendations to other state and county boards.

Please Note: Each committee may have more extensive responsibilities. You should contact the chair of your local committee for your local committee by-laws and to learn what is expected of you as a member.
