Or why not apply for a local board or commission - for example, if you live or work in Frederick City, the Public Art Commission is currently seeking interested individuals for multiple openings. Please feel free to reach out to us for more information about these kinds of opportunities.

> And of course, we'd love your help on the Central Committee - and yes, we're elected, so you'd have to file to add your name to the ballot. If you've ever attended our events,

donated money to the local party, worked a phone bank, or knocked on doors for

a candidate, you're already the kind of active Democrat who belongs by our side.

In other news, we're very excited to be returning to Rocky Gap, May 13-14, for this year's Western Maryland Democratic Summit! We're expecting all of the statewide candidates - gubernatorial, attorney general, and comptroller - as well as our current federal elected officials. Mid-Session Report

As I am writing this summary, we will be approaching the mid-point of our legislative session. I am the lead sponsor of eleven bills. While all of them are relevant to the entire state, Frederick County citizens and/ or community leaders inspired seven. These legislative efforts are:

- HB225- State's Attorney required explanation for denial of a sexual assault case
- HB267-Protecting Health Care Workers Against Threats of Violence
- HB293-9-8-8 Suicide Hotline Funding
- HB628-Preventing workplace discrimination against medical cannabis users
- HB1017- Assisted Outplacement Treatment option for chronic mental illness, Frederick pilot
- HB 1019- Increased Transportation Funding for the elderly and handicapped
- HB 1020- Strengthen self-direction choices for the developmentally disabled

- HB1 Referendum that would allow individuals 21 or older to use and possess cannabis.
- HB 837 Three main aspects to the bill: Criminal, Health, Regulatory

Criminal

Effective January 1, 2023

- Simple possession of 1.5 ounces or less is a civil offense, fine not exceeding \$100 and up to 2.5 ounces is a civil offense, fine not exceeding \$250
- Expungement (these two provisions will help over 550,000 Marylanders)
- -A person charged with only simple possession may have that charge automatically expunged.
- -A person charged with simple possession and other charges from a single event may file for expungement immediately. (ex. Firearm charge and possession happened at the same time)

-A person may request expungement for this conviction 3 years

after the sentence is satisfied.

- Possession with intent to distribute becomes a misdemeanor instead of a felony.
- Individuals currently incarcerated for simple possession can request resentencing and end their incarceration
- Effective July 1, 2023
- Possession of up to 1.5 ounces or less becomes legal, possession up to 2.5 ounces is subject to civil citation
- Marijuana cannot be smoked in a public place, it is subject to the Clean Indoor Air Act
- Can grow up to 2 plants in a single household, regardless of number of adults, in a secure location

Health

- Baseline Study so that the General Assembly can compare cannabis stats pre and post-legalization. This includes studying community health effects, use disorder, impaired driving, hospitals, advertising, etc.
- Other Cannabis Studies by the Medical Cannabis Commission to examine home grown for medical patients' personal use, on-site consumption areas, and youth impacts.
- Establish the Cannabis Public Health Fund to support the Cannabis Public Health Advisory Council efforts to continue studying the legalization of cannabis.

Regulatory

- Commission a disparity study to ensure Maryland's future licensing structure can pass constitutional scrutiny. The study will be finalized by Nov '22 to ensure the MGA has the results in time for next session.
- Creates a Minority and Women Owned Cannabis Business
 Assistance Fund to help individuals enter the cannabis industry.
 Funding will also be provided to support educational programs at
 HBCUs and business incubators, as well as for outreach to trade
 associations representing minority businesses.

During April, I will report on the status of my bills as well as the major 5 legislative initiatives of the session.

SENATOR RON YOUNG



As I start the last Session as your State Senator, I want to thank all of you for your years of support, openness with your comments, and suggestions for legislation. It has been my honor to represent you and Frederick county at the Maryland General Assembly.

The first week in March marks the half-way point of the 2022 Session of the Maryland General Assembly. My office is currently focused on getting a favorable vote from the Senate Education, Health, and Environmental Affairs (EHE) committee on Brynleigh's Act (SB299/HB136) and the School Lunch and Breakfast Program bill (SB971/HB857) from the Senate Rules Committee. On February 24th the House unanimously passed Brynleigh's Act (HB136) and now both the House and Senate Brynleigh Act bills are in EHE.

Also on February 24th, the Maryland Senate Democrats announced their commitment to pass paid family and medical leave legislation that is affordable for employers, employees, and the State. Marylanders cannot wait any longer for support during their most vulnerable moments. The press conference for SB275 can be viewed virtually on Facebook.

The Governor submitted his nominations to state boards and commissions on February 18th, kicking off what is known as the "Green Bag" appointment process. The first step in the Senate approval of the 131 nominees is a hearing before the Senate Executive Nominations committee. You can watch the hearings for the next couple of weeks on Monday nights at 5pm on Youtube. In State news Maryland's chief medical examiner resigned abruptly Friday February 18th as the office continues to navigate an unprecedented backlog. A years-long staffing crisis in the state medical examiner's office in Baltimore is leading to unprecedented delays in autopsies, an emergency request to federal officials for help, and now a legislative push for more workers.




March is Women's History Month

We are at the half-way point in the 444th Maryland General Assembly. I am pleased to say that two bills brought to me by District 3B constituents have successfully passed the house. The first is Brynleigh's Act—(HB136) a law that requires all school personnel working with students to be trained to recognize the symptoms of a seizure and know how to properly respond. Senator Young's cross-filed bill (SB299) also unanimously passed committee and is moving through that chamber on its way to the governor for his signature. The second is Presumption of Property Abandonment - Revisions (HB305). A constituent had deposited over \$100,000 in retirement savings believing it to be in a safe place until he needed it for retirement. It had no deposits of withdrawals in three years and, according to current law, was turned over to the state as abandoned. The banks' only responsibility is to attempt to contact the account holder a single time by 1st class mail. Assuming it was another marketing mailing from the bank, he ignored the envelope. He was able to get his money back, but, because he was under age 55, he had to pay a \$12,000 early withdrawal penalty. With the passage of this bill, the bank can no longer consider an account as abandoned if the account holder has other active accounts or if the bank has no mail returned as undeliverable. Both of these bills took a lot of work over three years to get all stakeholders to agree.

As Frederick County Delegation Vice Chair, the responsibility of working the Frederick County legislation through the house fell to me this session. We updated liquor laws with HB1234 Frederick County Alcoholic Beverage Act of 2022. Heritage Frederick will get some financial assistance in its maintaining

of historical marriage records as a result of HB452 Marriage Ceremony Fee. HB399 Sports Wagering Facilities – Locations gives Off Track Betting locations in Frederick and Carroll Counties a wider area of protection from competition (10 miles as opposed to 1.5) so that they can confidently make the sizable investments necessary to begin their sports book operations. A bill to permit a Frederick County High School permission to have students set up a coffee shop and a bill to change the way Board of Education vacancies are filled have also had good hearings, but have not yet made it to the floor for a vote.

By the next issue of The Banner, I should have news on my other nine bills--three of which are Cybersecurity related. Finally, the Lowe Office Building is open to the public, so come down and see us before we adjourn on April 11.



The Rest Of the Story

January marked the first-year anniversary of the Biden-Harris administration. Important mid-year elections are coming up, including in Maryland. The Biden-Harris administration started with relatively high approval ratings, but the ratings have slipped, primarily due to the re-emergence of COVID in the form of the Omicron variant, the missteps associated with the withdrawal from Afghanistan, increased inflation, and the inability of the Congress to pass the "Build Back Better" legislation and to do something meaningful about voting rights. Not helpful has been the completely false narrative that President Biden is not up to the challenges we face due to age. We now face a world challenge from Russia's completely uncalled for invasion of Ukraine. President Biden has been resolute in uniting our allies to oppose this threat to world peace but the outcome of that crisis is yet to be determined.

Democrats should not be dismayed. A serious look at the achievements of the Biden-Harris administration in their first year provides ample evidence of significant success. During the first year of the Biden-Harris administration a historic vaccination program was initiated, which has saved thousands of lives; 6.4 million jobs were added to the American economy; the Congress passed the American Rescue Plan and the bipartisan Infrastructure law; President Biden has provided much needed global leadership; the United States has rejoined the Paris Agreement in regard to the climate crisis; and an historic number of judges, including a large percentage of minority judges, have been appointed and approved by the U.S. Senate.

Some facts and figures to support the achievements during the first year of the Biden-Harris administration:

> The unemployment rate has dropped from 6.2% to 3.9%The number of persons receiving unemployment



benefits has dropped from 18 million to 2 million, the biggest single year drop in history

Nearly 5 million Americans have newly gained health insurance coverage

President Biden has the first ever majority non-white Cabinet in history

The United States has made the largest ever investment in the power grid, electric vehicle chargers, and climate resilience

The United States has made the largest investment to get safe and clean drinking water to all Americans

HUD announced that it would interpret the Fair Housing Act to bar discrimination on the basis of sexual orientation and gender identity consistent with President Biden's Executive Order 13988

President Biden reversed the discriminatory ban on openly transgender service members serving in the military

\$100 million from the American Rescue Plan went to the EPA for environmental justice priorities

By late January 2022 over 95% of schools were open for in-person learning compared to 46% when the Biden-Harris team was sworn in. \$122 billion from the American Rescue Plan will go to schools to help them stay open and address lost instructional time and students' needs

Over \$40 billion from the American Rescue Act will go to institutions of higher education including financial aid to millions of students

More than 15 billion dollars in federal student loans were discharged, affecting in excess of 675,000 borrowers

Due to the expanded Child Tax Credit, monthly checks of up to \$300 per child have been sent to roughly 35 million households, which is projected to cut child poverty in half Over \$500 million from the American Rescue Plan has gone to expand pediatric mental health care access and to assist programs to help children and adolescents with serious mental illness and substance abuse disorders

More than 75% of adults (including 88% of seniors) in the United States have been vaccinated

171 million dollars of stimulus checks of up to \$1,400 were delivered to Americans

The State of Maryland, as a result of the bipartisan Infrastructure law, is expected to receive 4.6 billion dollars over five years for highways and bridges, \$1.8 billion to improve public transportation, \$63 million to support the expansion of EV charging networks, and \$158 million for infrastructure developments for airports. Local governments can expect grants as a result of the infrastructure law to assist with traffic safety, local transportation projects, the purchase of zero and low emission transportation buses and facilities for buses, bridge and culvert repair or replacement, among other programs. In Maryland, as a result of the American Rescue Plan, 46,900 jobs have been created, and 2,791,138 Marylanders have received direct payments of up to \$1,400. The Maryland unemployment rate has dropped from 6.4% when the Biden-Harris administration took office to 6.0% and vaccinations have gone from fewer than 1% to 80.2%. In Maryland, 1,117,000 children have benefited from monthly tax cuts to their families. The average monthly reduction in ACA health premiums for a family of four has been \$259, and \$8,610 is the average annual savings on child care for a Maryland family with two young children as a result of the Biden policies. It is expected that the number of jobs saved or created in Maryland as a result of the infrastructure bill will be 276,280.

Much of the above information comes from the White House Office of Political Strategy and Outreach.

The Republicans will, of course, blame everything they can on the Biden-Harris administration and will stray far from the truth. As Democrats we need to be prepared to advocate for the significant accomplishments of the Biden-Harris administration. The coming election depends on it.



Elected officials need to understand the reality of climate change and act to mitigate its effects. I will include consideration of climate change when evaluating any legislation.

2022 Maryland Primary for Central Committee Candidates of the Democratic State Central Committee of Maryland

The Democratic State Central Committee of Maryland elects the **fourteen (14)** members of Frederick County by a countywide vote of their Democratic voters during the Gubernatorial Primary on **June 28, 2022**. Membership of the committee allows for representation of three (3) gender categories; **Male, Female, & Non-Binary.** When filing for candidacy, candidates will identify their preferred gender identity, which will appear on the official ballot alongside their names. **All candidates will appear under one ballot title.** Elections of the committee shall allow for gender balance ensuring that **no more than fifty (50) percent of the membership** is represented by one of the three (3) gender categories listed above.

Three Gender Categories:

Each candidacy filing form will show THREE (3) categories Male, Female, & Non-Binary. Non-Binary: "non-binary" is one term people use to describe genders that don't fall into one of these two categories, male or female.

What does gender balance mean?

Gender balance allows for equal representation between genders. The election process will take into account both vote total and gender representation. Through the election process, the committee will be considered gender balanced as long as there is **no greater than a variance of one (1)** between **Male** and **Female**, as **Non-Binary** will not count as either **Male** nor **Female**.

What DOES this mean:

- No more than a maximum of seven (7) members can be Male, Female, or Non-Binary.
- Candidates WILL have their preferred gender identity listed on the ballot with their names.
- In the case that a Non-Binary candidate wins a spot on the committee, the remainder of the
 committee will be balanced as equally as practicable between male and female with the remaining
 candidates on the ballot.
- There are no guaranteed slots to any one gender. Meaning the allocation of members is solely determined by vote total and gender balance allocation.
- There is **NO** advantage or disadvantage to selecting a specific gender category.

Role of Maryland Democratic State Central Committee Members

Central Committee members are the grass roots-level elected volunteers of the Maryland Democratic Party. They must be dedicated to working to ensure the election of Democrats to public office, while encouraging the participation of activists, volunteers and financial contributors. This calls for many hours of participation, and in some cases a financial commitment themselves.

They should bring to the Central Committee a strong commitment to the Democratic Party and all the things it stands for. Central Committee members should have volunteer experience in various political activities, worked for candidates, or run for office themselves.

Central Committee members are the people elected to work directly in the trenches on behalf of the Democratic Party and to organize an ongoing presence at the local level. They are the people who do the organizing and actual tasks of helping get Democrats elected. Central Committees members are not legislators. They are not managers or members of a board of directors, but worker bees themselves. They help organize and fulfill these tasks:

Fundraise, staff party booths/events, precinct organization, participate in canvassing operations, distribute political literature, perform voter registration, phone bank, and assist hands on in all of the tasks necessary for Democrats to be successful in elections.

Central Committee members have an obligation to attend all committee meetings, support party nominees, and to actively participate in all the activities of the State and Local Central Committee. Central Committee members at no time can openly support a candidate of another political party in a partisan race.

Central Committee members cannot do all that must be done by themselves, they must reach out and recruit volunteers to assist in many of these activities and tasks. Recruitment of volunteers therefore becomes the difference between success and failure. Central Committee members must have good motivational and organizing skills to make use of these volunteer resources.

As a member of the local Central Committee individuals are automatic members of the State Central Committee and are expected to attend Semi-annual meetings, vote on State Party issues and participate in State Party projects.

Central Committee members have the official responsibility to fill vacancies of certain offices due to death or resignation of elected official, and fill any vacancy when there is a failure to have a Democratic Candidate file for nomination. The Central Committee also recommends to the Governor appointment of the members and substitute members for the local County Board of Elections and at times makes recommendations to other state and county boards.

Please Note: Each committee may have more extensive responsibilities. You should contact the chair of your local committee for your local committee by-laws and to learn what is expected of you as a member.
