# **CHAIR'S CORNER**

Welcome to the first Banner of 2024! The Central Committee is diving right into business with its annual retreat this Saturday, 3 February, where we'll review our bylaws, update our strategic plan, draft our events schedule, prepare for our GOTV (Get Out The Vote) efforts for the election this year, and more. Our next regular meeting, open to the public, will be Tuesday, 20 February; we meet monthly on the third Tuesday at 6:30 PM. You can check our calendar for the most up-to-date information on our meeting locations, local Democratic club meetings, and other upcoming events.

Are you planning to run for office this year or want to be a <u>delegate</u> to the Democratic National Convention in Chicago? You have until next Friday, 9 February, to declare your candidacy. All Senate or Congressional District 6 candidates must file in person by appointment at the State Board of Elections in Annapolis. All Frederick County Board of Education candidates or those interested in being a Convention Delegate should file at the local Frederick County Board of Elections, 8490 Progress Way, Suite 300, Frederick. Please direct any questions to the local Elections Office at 301.600.VOTE (8683) or the State Board at 410.269.2840. If you do not run for office, consider being an election judge (aka poll worker). You can get the details on the Frederick County Board of Elections website, including how to apply, compensation, and more.

Over the next few months, the Central Committee will host a few major events. We do not have specific dates yet for most of them; however, we want to put them on your radar. In March, the local Democratic Clubs and Central Committee will cohost a joint forum for Democratic Senate candidates and one for Democratic Congressional District 6 Candidates. On Monday, 29 April, we will host our annual Frederick County Democratic Party Dinner at Dutch's Daughter. Additionally, we will host a "Spring into Action" Volunteer Orientation/Thank You Party and a Listening Session on TBD dates. We'll follow up with more information once everything falls into place for each event.

The Central Committee is looking for office space that we can call home for several months this year during the election or preferably through the general election in 2026. Last November Charles Peters died. He was 96. His obituary in the Washington Post on November 26, 2023, was headlined "Founder of muckraking periodical, Washington Monthly." I have been a long-time subscriber of the Washington Monthly. It was established by Peters in February 1969 and, as the Post reports, "trained a magnifying glass on the federal bureaucracy. The publication was likened at times to a self-appointed inspector general, such was its interest in holding obscure government agencies accountable." The Post obituary described Peters as "indefatigable and ornery." Peters was a veteran of Democratic politics in West Virginia and an early supporter of JFK for President. Under Peters' leadership the Washington Monthly, although without a large number of subscribers, became an influential publication and Peters was able to persuade such able political writers as David Broder, Russell Baker, Hugh Sidey, Murray Kempton, Bill Moyers, Taylor Branch, Jon Meacham, Michael Kinsley, David Ignatius, and Nicholas Lemann to contribute to the magazine. Some of them started as poorly-paid staffers

During my first term as president of the United Democrats of Frederick County, I suggested that the UDFC sponsor a conference and we did. It was called "The Democratic Party: Where Do We Go from Here" and it was held at Hood College on March 9, 1985. Speakers included Don Hutchinson (Baltimore County Executive), Lorraine Sheehan (Maryland Secretary of State), Michael Barnes (Maryland's 8<sup>th</sup> district Congressman), Ben Cardin (Speaker of the Maryland House of Delegates), Joe Curran, Jr. (Maryland Lieutenant Governor), Beverly Byron (Maryland's 6<sup>th</sup> district Congresswoman), Howard Thomas (chair of the Maryland Democratic Party) and others. The keynote speaker was Democratic Congressman David McCurdy, from Oklahoma. I was an avid reader of Peters' publication, so in searching for a nationally known luncheon speaker, I thought of Charles Peters. After a cold call to his office in Washington, he surprisingly agreed to be our luncheon speaker.

The first conference was so successful that the UDFC sponsored additional conferences in 1987, 1990, 1991, and 1995. The 1987 conference was called "Capturing the White House in '88" and featured Congressman Dick Gebhardt from Missouri as the keynote speaker and repeat appearances from Don Hutchinson, Beverly Byron, Joe Curran as well as Congressman Tom McMillen, and Kathleen Kennedy Townsend. The 3<sup>rd</sup> conference, in 1990 was held at Frederick Community College and focused on local issues, and the theme was "Planning for Growth - A Regional Perspective." The 4<sup>th</sup> and final conference in 1995 was again at Hood College, and theme was "Maryland Democrats: Crafting A Winning Message for the 1990s." I cannot locate the program from that conference, so I cannot recall who the speakers were.

The efforts of the U.D.F.C. in sponsoring conferences may have something to do with the fact that the Maryland Democratic Party (MDP) had a state conference in December 1987 entitled "Maryland Democrats Working Together" at the University of Maryland Baltimore County. I was on the planning committee for that conference, and it featured a host of Democratic party luminaries, including William Donald Schaefer, Louis Goldstein, Barbara Mikulski, Peter Franchot, Tom McMillen, Maggi McIntosh, Clarence Blount, Kurt Schmoke, Paul Sarbanes, Cas Taylor, Parris Glendening, Mike Miller, Beverly Byron, Steny Hoyer, and many others. In 2000 the MDP held another conference in Prince George's County with the title "A Call to Organize" which featured a keynote address from National Democratic Party Chair Roy Romer and included Steny Hoyer, Taylor Branch, Celinda Lake, Fred Yang, and MDP Chair Peter Krauser.

For the past twenty years, the Western Maryland Democratic Caucus has filled the void in regard to conferences by sponsoring the Western Maryland Democratic Summit.

On January 1 of this year, we lost a wonderful public servant and an especially nice person with the passing of Marcia Hall. Marcia, a librarian by trade, was an enthusiastic reader, walker, and doer of good. She was active in the League of Women Voters and the U.D.F.C. She was elected to the Frederick City Board of Aldermen (that word, hopefully, will soon change) in 2001 and re-elected in 2005. On the Board of Aldermen, she brought to the table her inciteful intelligence, good common sense, and commitment to doing the right thing. I enjoyed going door-to-door with her in 2005 when we were both running for the Board of Aldermen (she finished first and I finished 8<sup>th</sup>!). She and her husband, Jerry Quance, moved from Frederick, first to the Eastern Shore of Maryland and then to Kansas City to be near family. She will be missed for her bright smile and exuberance.

#### Summary of Bills:

#### City of Frederick - Assignment of Offenders to Road Work – Repeal

HB \*\*\* is a repeal of a 1917 Jim Crow law that took effect in Frederick in 1957 and

is still on the books. As the law currently reads, it allows the courts and law enforcement to require those who are considered a "vagrant" to do roadwork in Frederick City or County. This is an outdated, archaic practice in Frederick where we believe these community members need assistance in areas such as housing, food stability, and job opportunities as opposed to forced labor. We hope this bill will be supported by our Frederick Delegation.

## HB 311 - Child Support - Suspension of Driver's Licenses

The purpose of HB 311 is to establish due process for the suspension of driver's licenses due to child support arrearage. HB 311 seeks to reduce the number of inappropriate suspensions while ensuring that the decision is appropriate and useful in serving the best interest of the child. We want parents to keep working so they can continue to support their children.

HB 482 - Criminal Injuries Compensation Board - Victims of Nonfatal Strangulation

HB 482 outlines that the Criminal Injuries Compensation Board covers the cost of certain examinations and services in cases of nonfatal strangulation. This allows qualified healthcare providers to be reimbursed for immediate care and follow-up services up until 16 days after the alleged crime. This legislation also protects health care providers who are caring for victims of child sexual abuse from persecution by law due to failing to receive guardian consent to treat the child's injuries.

#### HB 62 - State Employee Rights and Protections - Personnel Actions and Harassment - Investigation of Complaints

The purpose of HB 62 is to increase the amount of time for an investigation and written decision to be issued regarding complaints alleging discrimination or harassment by a State employer. This legislation allows for additional time to be granted to the investigation, only if the alleging employee has given their written permission to do so.

#### HB 406 - Marriage - Confidential Communication - Criminal Charge

HB 406 establishes that an individual, who is an alleged victim of their spouse and is bringing criminal charges against said spouse, is allowed to disclose confidential communication between them if relevant to the criminal charges. However, this legislation also states that an individual may not be compelled to testify about confidential communications between themselves and their spouse that occurred during their marriage. It is a choice to empower victims of intimate partner violence.

#### HB 445 - Minors Convicted as Adults -Transfer to Juvenile Court

HB 445 allows the court to transfer the sentencing of a minor as an adult back to juvenile court under specific circumstances. This decision is made if the person in which the minor committed a crime against is found by

clear and convincing evidence to have committed a sex crime or trafficking crime against said minor. Once they have determined this, the court has the discretion to move the minor back to juvenile court to be sentenced.

#### HB 274 - Intercepted Communications - Penalty

HB 274 reclassifies the charge of intercepting and disclosing any wire, oral, or electronic communications from a felony charge to a misdemeanor charge. Most people have smartphones that can record video. Many don't realize they need explicit permission to record someone else. And victims of violence shouldn't risk further harm by asking their perpetrators for permission before recording a crime. This legislation imposes a less severe punishment than the current felony charge.
