It was a cold day, but our red hot passion for democracy will not let us stay silent when so much is at stake. We have an economy to save, jobs to save, healthcare to save, research to save, USAID to save, DEI to support, and much more to do."

Since then, the Department of Education, Medicaid and Social Security have been attacked, and the Smithsonian and other museums are

now subjected to having federal dollars pulled for having content that promotes "divisive, race-centered ideology [sic]." Folks, none of these executive orders are designed to help anyone and shouldn't be ignored as just another crazy thing that Trump and his unqualified and incompetent administration are doing. And don't get me started on SignalGate, which was clearly a conversation that illegally discussed classified information about the attack on Yemen over a commercial (i.e. unsecure) platform. While all of this is crazy, it's not funny crazy. It's downright horrifying.

This Saturday, our DCC and Rise Up Frederick are hosting another protest and march in response to the National "Hands Off" Protest and Day of Action. If you can't make it to DC, please join us. The Rest of the Story – Democrats and Rural Voters

Last month marked the 20<sup>th</sup> anniversary of the death of Richard Grumacher, who died on March 4, 2005, at the age of 90. Grumacher was an army veteran who worked in his family business, Bon-Ton Department Store. He was elected three times to the Maryland House of Delegates and served from 1961 to 1974. He sponsored legislation supporting civil rights, civil liberties, and consumer protection. He was a delegate to the 1967 Maryland Constitutional Convention and active with the A.C.L.U., Planned Parenthood, and the Maryland Advisory Council on Mental Health. In 1960 he was a delegate to the White House Conference on Children and Youth and was on the Advisory Committee to the U.S. Civil Rights Commission. From 1982 to 1988 he served on the original board for the Maryland Legal Service Commission, which was set up to provide legal services to the less fortunate. He helped coordinate the 1972 Maryland McGovern for President campaign. What is surprising about Grumacher is that he represented Washington County in the Maryland House of Delegates! In 1960 he was appointed to the Maryland House of Delegates to replace Delegate Charles Coss, who had resigned to join the Kennedy administration to work in economic

development. Charlie Coss was a strong union supporter and later moved to Frederick County and was active in the United Democrats of Frederick County. During the time that Grumacher served in the House of Delegates, he represented all of Washington County. Today, except for the oasis of the city of Hagerstown, Washington County is Trump country.

House District 4A was created after the 1970 census. Charles Smith was elected as District 4A's first delegate in 1974, and he was re-elected in 1978. District 4A was south, east, and north of Frederick City and included Johnsville, Mt. Pleasant, Woodsboro, Urbana, Linganore, Mt. Airy, Walkersville, Brunswick, Liberty, New Market, Buckeystown, Adamstown, and Point of Rocks. In 1981 there were 23,844 registered Democrats in the District, 15,432 registered Republicans, and 2,420 registered independents. Smith was considered a moderate Democrat at that time. The district became a two-member district in 1982, and Smith was defeated in the Democratic Primary by Tom Hattery and George Littrell who both were elected to the House of Delegates in the 1982 general election. They both served three terms until the 1994 election when Tom was defeated for re-election and George was unsuccessful in his attempt to replace Democrat Charles Smelser in the Maryland Senate in Senate District 4. House District 4A during the time that Tom and George served was essentially the same as the district in the 1970s with the addition of Thurmont, Myersville, and Lewistown. The district in 1983 contained 13,567 Democrats, 8,922 Republicans, and 2,152 independents. Tom and George both had a moderate to liberal voting record in the Maryland General Assembly. Today, much of the area that was included in District 4A comprises District 4, which is represented by a Republican state senator and three Republican members of the House of Delegates.


Except for Brunswick, Urbana town center, and a few new developments near New Market, district 4 is overwhelming Republican and Trump territory.

Traditionally, before this century, Democrats in Frederick County were organized by election districts. Each election district had a Democratic committee with officers. On June 27, 1994, Jefferson Democrats met and elected officers: Merhl Remsberg (chair), Charles C. Smith (vice chair), Dorothy Long (secretary), Doris Ifert (treasurer), and committee members Tom Arnold, Nancy Gordon, Joe Bill Kelley, George Lakin, Henry Lakin, Jr., Joe Long, Daniel Poole, Helen Remsburg, and Floyd Wickless. Most of the Democrats on the committee were associated with the Jefferson Fire Department, and the Jefferson Ruritan, and/or were active in the agricultural community. Charles C. Smith (not the same Charles Smith who served in the House of Delegates), a Jefferson farmer, was elected several times to the Frederick County Board of County Commissioners as a Democrat. Voter registration in Jefferson in 1992: 662 Democrats, (46.6%), 633 Republicans (44.7%), independents 122 (8.6%). Today, I would guess that the majority of members of the fire department, the Ruritan, and the agricultural community in Jefferson are registered Republicans. In 2024 Trump defeated Harris in the Jefferson district 1900 (55%) to 1489 (43%). Put Jefferson in the Trump camp.

When my son, Stephen, and I presented an analysis of last year's presidential election, Stephen provided a slide that showed all of the counties in the United States with those that were carried by Trump in red and those carried by Harris in blue. Almost the whole map was red. The blue was almost exclusively in the east, some Great Lakes states, and parts of the west coast, basically in urban and some suburban areas of the country. One state, Oklahoma, had no blue counties. As recently as 2008, Obama

won Florida and North Carolina as well as Indiana. He managed to carry Florida again in 2012. Biden won Georgia in 2020. Otherwise, in the last 20 years, the south and the heartland of America has been solidly red. West Virginia, once a solid blue state has become an especially strong red state and definitely a Trump bastion.

The Democratic Party has a rural problem. We are not competitive in areas of the country that we historically have been competitive. I do not have the answer as to how to deal with this issue, but the Democratic Party, locally, in the State of Maryland, and in the nation needs to devote some of its energy to developing a plan as to how we can compete in rural areas of the county, state, and nation.

**State Delegate, Ken Kerr**

As I write this, we are two weeks away from Sine Die. Today is March 25<sup>th</sup> and we are listening to hours upon hours of Republican amendments the budget and BRFA. We are 76 days into the session and have heard nothing from the opposition about what they would cut and what revenues they would generate—until today. Suddenly, they have programs they don't want cut coupled with revenues they don't want to support. Disappointing, but not unexpected.

We are on the other side of Crossover. I sponsored 15 bills this session. At the advocates' request, I withdrew two of them. In all, 12 of the 15 passed the house and crossed over to the senate. HB297 repeals the sunset on the Young Worker Subsidies bill. This law has been very successful in making healthcare affordable for young workers (18-37) and in keeping all premiums low by adding young health people into the risk pool. HB298 creates a commission to study college students who have dependent children. Nationally, only 18% of this population complete a degree within 6 years as compared to 61% of the traditional student population. With 80% of new jobs in Maryland requiring a degree, we need to get these students connected to these jobs. HB300 helps our non-profits by allowing them to use 15% of grants for indirect costs relieving pressure on their operating budgets and overhead

expenses. HB304 provides increased transparency in state procurement practices making it easier to do business with the State of Maryland. HB333 creates a workgroup to study cybersecurity in Maryland’s hospitals. HB345 includes Maryland in an Interstate Social Worker Compact allowing social workers to practice across member-state lines. This is especially helpful to military spouses. HB507 codifies into Maryland law, contract provisions the University System of Maryland is prohibited from entering into—specifically “indemnification.” HB508 specifies what type of work Maryland Blind Industries is eligible for in no-bid contracts. HB723 makes it easier for Dental Hygienists trained in other states to practice in Maryland. HB780 allows municipalities to reduce the speed limit on state roads that run through the town by 5MPH without requiring a traffic study. HB1027 advances the implementation of a statewide 3-1-1 non-emergency constituent assistance system.

All my bills are now in the custody of the senate and have to make their way back over to the house before midnight on April 7<sup>th</sup>. Meanwhile, we are putting in long days and late nights and the occasional Saturday as the 2025 Legislative Session marches toward Sine Die. Senator Lewis Young, Delegates Fair and Simpson and I hope to see you on Monday May 5<sup>th</sup> at Café 6-1-1 for a legislative wrap up.

**Lower-Income and Rural Students Already Paying the Price After Trump Abolished Department of Education**

Donald Trump’s reckless agenda shutting down the Department of Education is already hitting our public schools and is set to [delay](#) grants for student aid and [pause](#) new programs in lower-income and rural communities. With help from billionaire Education Secretary Linda McMahon, Trump is pushing [another unpopular](#) pillar of his Project 2025 blueprint — and 50 million public school students will suffer.

*Here’s a look at how Trump’s order to abolish the Department of Education hurts low-income and rural students:*

[NPR](#): “Education Dept. cuts could hurt low-income schools.” ... “[T]oday, nearly all the statisticians and data experts who help get [certain federal education grants] to schools could be out of a job.

“The action essentially tells U.S. Secretary of Education Linda McMahon to take all necessary steps toward eliminating the department to the maximum extent possible ... **The National Center for Education Statistics, the agency that will have all but three staff workers eliminated, works on ‘formula grants.’ States and districts primarily decide what to do with these funds.** For example, Title I and rural school grants could be used to pay for school staff salaries, transportation costs, technology and extra tutoring.”

[USA Today](#): “Already, college officials say they have a backlog of logistical questions building up now that fired federal workers have stopped returning their emails. **“Brenda Hicks, the financial aid director at Southwestern College, a private school in Kansas, said an employee at FSA who was helping greenlight a new nursing program at her institution was let go last Tuesday. The program was started, Hicks said, so that young people in her rural community wouldn’t have to drive an hour out of town to become nurses. ...**

“The day after the Education Department announced staffing cuts last week, students nationwide briefly couldn’t apply for financial aid. ... **“More than 320 employees in the Federal Student Aid office received termination notices last Tuesday, according to a preliminary tally from a union representing federal workers.”** [NPR](#): “[T]he federal government plays an outsize role in helping high-needs schools get the money they need to stay afloat.

“Congress established Title I to provide money to K-12 schools in low-income communities. In the current fiscal year, the Department of Education set aside more than \$18.38 billion for Title I. Nearly 90% of U.S. school districts benefit from the program, which has historically enjoyed bipartisan support among lawmakers. **“The Rural Education Achievement Program (REAP) awards money to low-income and rural school districts. More than a quarter of the country’s public schools are in rural areas. And while REAP is a fraction of the size of Title I — \$215 million for the current year — Amy Price Azano of Virginia Tech’s Center for Rural Education says those dollars stretch much further in rural communities. ... “These federal grants can pay for things like school staff salaries, supplies, technology, tutoring programs and a range of basic services that low-income schools may not otherwise be able to afford [...] while rural schools are used to having fewer resources, the loss of REAP funds will strain them even more.”**

[NOTUS](#): “All income-driven repayment plans, the umbrella under which ICR plans fall, use the same application that was closed after the February court order, as the administration says it is revising it. The American Federation of Teachers sued the administration Wednesday morning for removing the application.

**“The lack of clarity – from both the court decision and the Department of Education’s limited communication with respect to the issue – has sowed fear and outrage that the programs might be eliminated.** Without income-driven repayment plans, borrowers worry that their monthly payments would balloon to what they would be on the standard plan – for some borrowers, the difference could be hundreds of dollars.”
